Form C – For Claims by Operational Creditors (except workmen & employees)

Form D – For Claims by Financial Creditors

Form E – For Claims by Workmen & Employees

Form F – For Claims by authorised representative of Workmen & Employees

Form G – For Claims by any other stakeholder

Last date for submission of the claims is 21.09.2018. Any claim which is being made after 21.09.2018 shall not be entertained by the Liquidator. Hence, I request you to submit your claims on or before 21.09.2018.
